

## Why we should support the WSSR-PAC

Why should we support the Washington State School Retirees Political Action Committee (WSSR-PAC)? This is a good question that is easily answered. Support for our PAC is an example of enlightened self-interest. Our political action committee was formed to provide influence on legislation that affects pension benefits and other retirement issues. By giving campaign support to those state legislator candidates friendly to our interests, we are working to promote the general welfare of our members.

It is imperative that we have support in Olympia for those issues that influence our quality of life. Who else will speak for us if we don't do it ourselves? WSSRA provides such a voice for us. Our organization lobbies for the passage of positive legislation. We send members regularly to Olympia to talk with legislators about pending issues. This is the chief function of our legislative committee. Additionally, we draft bills and amendments to submit for consideration during the legislative session and we employ professional lobbyists to assist with this task. Our dues help finance the costs of these efforts.

The other essential element to this whole process is campaign support to candidates seeking state office. If we can promote candidates who are supportive of our issues through our financial support, time, and effort, we enhance our chances of success.

However, by law we cannot use member dues money for political campaigns. Funding for campaign purposes must be raised separately through a PAC. These funds must be held and expended by a committee of volunteer members. Legally our PAC must be considered a separate entity from WSSRA. For that reason, voluntary contributions must be solicited from our members. It is a truism that money and personal effort are what fuels campaigns. Money talks! If we are ever to increase our ability to influence the outcomes of the legislature, we must be able to contribute meaningfully to campaigns.

## **HEALTH SERVICES**

A Wealth of Information for Your Health: Though targeted to men, the partner in life should share the advice from a group of doctors at Northwest Hospital, Seattle. They reviewed what men should do to age gracefully. They agreed that number one is to establish a good care relationship with a physician you can trust, and number two is to gather a complete family medical history. This information pinpoints your risk of heart disease, diabetes, prostate, colon cancer or high cholesterol, etc. Discuss the family history (and give a copy) so your doctor can know you are at greater risk and can be alert to advise you on preventative health care.

For the young who say, "Nothing's going to happen to me", urge them to think of physical exams like tuneups for your car, advises Dr. Lacambra, family practioner at Olympic Medical Center. He says, "If you get them regularly, you will be able to catch something before it becomes a big problem later on".

Age 40 is a time of increased concern for health, get a few tests - vision, cholesterol, etc. but at age 50 and beyond, be alert to what is happening to your body. Dr. Vara Kraft of the medical center says, "By this age, men should have routine colon cancer screenings, know their cholesterol levels and should be screened for diabetes". Dr. Kraft cheers us with this advice, "Don't just accept that you are getting older. Fifty is young. Be your best at any age".1

Genetic/Worldwide Research Update: The SKSR November '09 *Bulletin* had a brief article on Seattle's Institute for Systems Biology (ISB) and the goal of identifying defective genes that cause cells to malfunction and cancer to develop. ISB is working to identify drugs that will target the problem and provide treatment before cancer grows.

A Seattle Times front page update article and photo of founder Dr. Leroy Hood, along with revenue sources for the non profit company were all covered in the April 6, 2010 issue. Drs. Hood and Alan Aderem of ISB are being recognized worldwide as the leaders of research in systems biology. As an example of their successes, the small country of Luxembourg chose to contract \$100 Million with ISB to produce a study of genomes in 100 Luxembourgers to identify variations linked with diseases and drug response. Watch for more from ISB that has made an amazing record for only 10 years in business.2

Thyroid Problems Can Sneak Up on You: Women have thyroid disorders about five times more so than men and it increases with age, according to Dr. Elizabeth Smoots, medical column writer. She points out that it is difficult to diagnose or unable to at all.

This tiny gland in your neck regulates your metabolism, can affect your health from head to toe; an under active thyroid can cause fatigue, depression, weight gain, dry skin, hair loss, hardening of the arteries and other problems. A simple blood test can diagnose most thyroid problems. Ask your doctor!3

## **Legislative Report**

On April 1, Governor Gregoire signed SSB 6584, *Monitoring and reporting customers complaints and appeals to the State Health Care Authority*. Present at the bill signing ceremony were WSSRA representatives Rita Requa, president, Ester Wilfong, Legislative Committee Co-Chair, Ed Gunion, executive Director, and Leslie Main, Legislative Coordinator. They were joined by Senators Karen Fraser (D22) and Karen Keiser (D33) as well as representatives from the Retired Public Employees Council.

Congratulations and thanks to all of you for your efforts in passing this bill.

E2SHB 2617, Eliminating Boards and Commissions, passed but the Select Committee on Pension Policy (SCPP) was retained in the enacted version of the bill. This commission is very important to us as it gives current and future retirees a forum to have their pension concerns addressed. We were thankful that the SCPP was not

included in the final bill.

There is great concern about the full funding of Washington State's to Plan 1 and Plan 2/3 pension systems. Our state treasurer feels we will need an amendment to force the legislature to fully fund the system. Watch for more information on this important concern.

Even though the Legislature is adjourned (finally), we need to keep in contact and voice our concerns. I also hope that more people join the telephone tree as it is important to put pressure on our representatives. We activated it three times during this session.

## CRISIS IN HAITI: HOW YOU CAN HELP

His focus with them lasts over several years, and he allows his viewers a tremendous insight into their most difficult inner feelings as they deal with their own special needs and problems. At the meeting one such video focused on a young boy and girl dealing with the death of their mother, their personal guilt, and how time allows them healing. A second one focused on two boys who had to deal with their place in a family, their conflict between themselves, and

how they overcame their deep negative feelings for one another. Rick provided the audience a rare introspective view of problems faced by these young people, one that adults are rarely given an opportunity to see.
