It was after their month, 7000 mile Mountain Bike expedition from Seattle to La Paz, Bolivia that they decided to open their own business, Mountain Minded on Lopez Island. On their trek they sewed much of their own panniers (bike storage packs) and from 1988-1994 they marketed their own designs of expedition quality gear. In 2000, they had a 121 day kayaking adventure from Glacier Bay, AK, 1200 nautical miles and finally clearing customs at Friday Harbor in the San Juan Islands. In 2004 they travelled 1850 miles kayaking around the tip of South America in Chilean Patagonia. And then in 2007 Karen and Rob began a 3 month 1450 mile trek from Skagway, AK to Kaktovik on Beaufort Sound in the Arctic Ocean. This trek took two tries to complete and was finally achieved in 2010. It was a wild, difficult, beautiful and hazardous trip. The mosquitoes, alone, had us all aghast! We

were delighted to be the first to view their expedition at this worldwide premier showing!

#### **Telephone/Email Alert Team**

This past legislative session was a brutal, frustrating session. A large group of our members were part of our telephone/email Alert Team. They deserve a special thank you and a round of applause. There were 5 alerts from our state office, plus we sent some of our own. That special team would immediately call or email their legislator with our message.

Even though the budget eliminated our COLA's, they did receive our messages. There just wasn't enough money, and they did increase the minimum pension payment.

The revenue reports for the state continue to be down so far. It will be another difficult battle this year. We are hoping to double our Alert Team. It means that every one would continue to be on the team plus many other members to sign up. It doesn't take much time. This is also a way for actives to participate. #### **HEALTH SERVICES** by Gordon Bowers

**SKIN, CANCER REMINDER:** It is that time of year. A local doctor, Jeffery Ward is a medical oncologist at Puget Sound Cancer Centers who gives a good summary of this problem. Even from childhood when we sunburned badly, we are at a lifetime risk, even so, if most time is spent indoors. A tip to avoid cumulative damage: Stay out of the sun at its brightest...10 AM to 4 PM.

The battle with skin cancer has three phases: prevention, early detection and treatment. Use sunscreen with SPF 15 minimum containing titanium dioxide to block UVA and UVB. Use tightly woven clothing. Tanning beds are a NO NO!

Early detection means exam your body once a month, use mirrors, look for moles larger than one quarter of an inch that are new, likely to itch or bleed; may be irregular in shape, multicolored or bleeding.

Treatment involves some new drugs, interferon, Ipilimumab are tools used by oncologists, and surgery is the old standby.

Dr. Ward urges, "Buy wide brimmed hat, stock up on the right type of sunscreen, grab a hand mirror and take anything funny looking to your doctor."

TRICKS OUR BRAINS PULL ON US: have had a deluge of brain teasers on how certain clues affect our minds and behavior. A Cornell University professor, Brian Wansink, intrigued by how peoples mental - emotional reactions were changed by the environment. His position at the college was director of the Food and Brand Lab. He studied behaviors influenced by clues. For example, a restaurant operator called to say that business was bad and what can we do to bring in customers? The answer from the food director was to change the names of the foods they were serving; instead of Italian Pasta, list it as Tuscany Pasta, instead of chocolate cake, call it Black Forest Cake. Sales jumped 27%, people rated the restaurant as better, the chef more competent, staff excellent, all from external clues.2

In another experiment on brain teasers, University of Washington Professor Alan Marlatt arranged a wine party for graduate students. All labels were removed from the bottles and students were told two wines were either from North Dakota or California. If students thought the wine was from California, they rated the wine as better, the food better and stayed longer. When students drank the same wine thinking it was from North Dakota, they didn't think either the wine or food was good and left early, unhappy. Amazing how external clues can change behaviors, tastes and attitudes.<sup>3</sup>

AMERICAN HEART ASSOCIATION ANNUAL REPORT: This Scientific Sessions Report has in depth studies on heart problems, some new in the medical world: Women with jobs that are high strain have a greater risk of heart disease – 40% higher than women with low stress jobs. Researchers say that the strain results from having little or no control over a demanding job.

More regarding high blood pressure: Deaths from heart disease and stroke vary by geography, race and sex as reported in *Hypertension Journal* of the American Heart Association. The study's lead author, Deborah A. Levine, M.D. MPH says, "Where you live, your race and gender strongly influence your risk of developing high blood pressure as you move from young adulthood into middle age, and hypertension is a major risk factor for heart disease and stroke."

Between 1968 and 2006, deaths from heart disease and stroke fell 65%, but deaths from the same are still higher in the southeast US, higher for blacks, especially black women. Dr. Levine urges that, "People at high risk can benefit from close monitoring of their blood pressure and paying attention to risk factors such as obesity and physical activity.<sup>4</sup>

GOOD HEALTH NEWS: For the first in our lifetimes, women's death rate from lung cancer has reduced. It's a small reduction, but hopefully may be a trend. Lung cancer in men started reducing a decade ago, but cancer deaths of all types are still a disease of older adults who are

increasing in numbers. So it may be a challenge to maintain gains. The American Cancer Association spokeswoman, Elizabeth Ward said, "It looks like we have turned the corner; we think the downward trend is real, and we think it will continue."5

Carrie Misener, 3rd grade teacher at Brookside requested funds to build up her collection of nonfiction books. She purchased books about different animals.





# **Legislative Report** from Rita Requa

in May and passed laws and a budget that profoundly recommendations. affects both active and retired members of SKSR.

#### **FOR RETIREES:**

In the budget there is a reduction of the explicit <a href="mailto:rrequa@comcast.net">rrequa@comcast.net</a> medicare eligible subsidy for health insurance from \$182.50. To \$150. And according to the Health Care **President's** Authority, regardless of which medicare plan one has, Goals" (Louie Osmonovich) premiums will increase: Uniform Medicare Plan - a Special Honor-Betty Odle was honored for having 31% Increase from \$194.13 to \$255.00; Group Health attended 29 WSSRA Conventions! from \$137.51 to \$147. These changes will take effect January 2012. At this time there is no information about PEBB expected higher co-payments or higher deductibles. That information will be sent to you sometime in late summer-early fall. How will this affect you? Add \$32.50 and the increase in premiums to see how your health insurance costs will be increased for 2012.

SHB 2021 passed; the Plan I COLA is GONE. The Uniform COLA used an "annual increase" amount which increased by 3% a year, which when calculated with the retiree's number of years of service, resulted in a monthly benefit increase. The COLA will be \$1500 a month, the COLA is gone for you.

#### **FOR ACTIVES:**

The budget cut approximately \$2.5 billion from public education over the next two years, which included pay cut of 1.9% for nearly all educators. Unions and school boards will have to tackle the pay cuts locally. The budget suspended the voter-approved Initiative of 728 and 732 which funded smaller class sizes and educator cost-of-living adjustments.

WSSRA was successful in foiling attempts to raise to last. Start savings NOW!" (Alice Bingaman) the Plan 2 & 3 retirement age to 65. The retirement age for Plan 2 & 3 is retained at 62.

Because of I-1053 legislators were unable to raise the revenue needed for education and retirement purposes.

I hope those developments make you angry. Ellie Bonnano has decided to retire from the WSSRA Legislative Legislative Committee. Your new Committee member, Rita Requa, is meeting 32, and 21st to discuss retirement issues;

1. Our anger about abolishment of the COLA which we want reinstated as soon as possible.

- 2. Immediate stop of "take aways" i.e. health benefits
- 3. Positive steps to stabilize the pension system (PERS The Washington State Legislature completed its work and TRS 1) and support of Treasurer McIntire's

> Treasurer's Session—"I attended this session and several speakers spoke briefly about record-keeping, building a budget, and audits. Audits should be done whenever there is a change in treasurers and bank accounts and the checkbook should agree." (Donna Murrish)

Outreach Committee on Newsletters-Bruce and I presented a session on Newsletters.
