# **Latest Legislative Information**

At the time of printing, this is what has happened to legislation affecting retirees so far. The house has passed two important pieces of legislation benefitting our members. HB 1737 would allow Plan 2 & 3 members who retired before age 65 to substitute teach without penalty. HB 1168 fixes an error that restricts PERS 2&3 retirees their right to work. Both of these bills passed the House. Similar bills in the Senate either died in committee or did not get a hearing. The Senate can still act on the House bills. There has been no talk recently of reducing or eliminating our PEBB health benefits. That doesn't mean there will be no action on those benefits as funds for that program are included in the final budget, which is usually the last item on the agenda before adjourning. So be alert to notices to contact legislators about any of these issues.

Contacting your legislators directly through email ensures that the legislator will personally get the message. Phone messages go to the Legislative aide and not necessarily to the Legislator. Here is contact information for the 1st, 21st, and 32nd legislative districts.

# NEWS FROM NW-1 Coordinating Council Meetings Jan 5, and March 2, 2015

- •In January, seven SKSR members attended the NW-1 meeting in Mt. Vernon. This Council meets 3 times a year to bring together all the Northwest local WSSRA organizations. It is a time to hear what other organizations are doing and to learn about and collaborate on issues/concerns that we wish to communicate to the state Executive Board. After hearing the local and state reports, our focus was on suggestions for ways to reduce costs/spending by WSSRA and on ways to control the State Convention costs and to enhance/improve the overall convention activities. We had some lively discussion and excellent recommendations from reducing the number of Journal publications, to reviewing ways to hold state committee meetings more economically. At the convention having a single Keynote speaker would provide time for more breakout training sessions. These ideas and more will be taken back for further discussion by the state board.
- •In March, 5 SKSR members attended the NW-1 meeting in Mt. Vernon. This meeting focused on two primary matters: WSSRA Executive Director, Ed Gonion's retirement and what is happening in the State Legislature. Rita Requa gave a brief speech reflecting our appreciation and thanks for all that he has done on behalf of retired school employees. He will be further recognized at the WSSRA convention in June. As for the legislative concerns, they remain focused on the Health Benefit, pensions and colas and the bills to allow retirees to substitute without penalty. It is critical to maintain contact with your legislators.

#### **DID YOU KNOW?**


Peel a banana from the bottom and you won't have to pick the little stringy things' off of it. That's how the primates do it.
