#### YOUR PEBB HEALTH CARE FOR 2016

By now you should have received For Your Benefit booklet which explains changes in all the PEBB programs and premiums and a personalized letter explaining your present specific plan premium changes for 2016. If you are confused or need more information go to one of the benefit fairs.

If you need to take action on your health plans, do so before the deadline, *November 30*. Changes will be effective January 1, 2016.

#### SPECIAL ELECTION

The results of the November election in District 30 (Federal Way area) may determine the makeup of the State House of Representatives. A record amount of money has been collected and spent in those races.

#### **WASHINGTON STATE LEGISLATURE**

The 2016 Legislative Short Session (?) convenes in January. Topmost issue will be funding education to satisfy the Supreme Court decision which held the legislature responsible

for failing to live up to the state's "Paramount" duty of amply funding schools and imposing \$100,000-aday fine. There has been no call to hold an emergency session as I write this. Will our retired health benefit be on the line again to fund public education? Will the Legislature really cough up the \$100,000-aday fine and, where will that go? Will the Legislature find the will to raise revenue?

The Senate Education Committee October listening tour was scheduled in six different cities across the state to get citizen input regarding how to fund education. A new statewide salary schedule? A new way with special levies? Was the three billion dollars needed to "amply fund" education addressed or even mentioned?


## Le Bistro in October

Shoreline Schools Superintendent Rebecca Miner brought attendees up-to-date with some of the things happening in her district: Each elementary school will have a full-time counselor; each building will have instructional support teachers; teachers received their COLAs, plus a salary raise. Last year, the district teachers' salary level was 16th in the Puget Sound area, and now they are eighth.

After a delicious dessert, Jake Henderson, Western Region Vice President of Association Member Benefits Advisors (AMBA), shared information about the benefits available to WSSRA members. There are a large number of free benefits, i.e., Apple and Dell computers discounts, dining discounts at local restaurants, and travel.
