## April 13, 2016 Executive Board Minutes

Legislative – Rita reported that the PEBB state reimbursement option remained untouched. The merger of the Firefighters plan with Plan 1 was dropped. The Sub bill allowing retirees who took advantage of the Early Retirement Factors passed. Now they may sub up to 867 hours per year. This ability to sub will last for 4 years.

Membership – Jim reported that we have 1358 members with 12 pending. He talked about the honorary membership policy, which the State Executive Board was able to change. If a member obtains the age of 90 by June 30, they will no longer be required to pay dues.
