



# LEGISLATIVE UPDATE - GORDON BOWERS

The WSRTA COLA BILL, Senate Bill No. 6333 is in the Senate Ways & Means committee. As soon as action begins on the Senate Bill, the same bill will be introduced in the House. (A copy of the Bill is below.) Sno-King members should phone or write their legislators, urging them to ask Ways & Means committee members to hold hearings on the teachers COLA bill. After hearings are held, the Ways & Means committee must pass the bill to the Rules Committee which must send it to the main body of the Legislature for action.

#### SENATE BILL NO. 6333

State of Washington 50th Legislature 1988 Regular Session

Read first time 1/19/88 and referred to Committee on Ways & Means.

1 AN ACT Relating to the teachers' retirement system; and adding a 2 new section to chapter 41.32 RCW.

#### 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

- 4 NEW SECTION. Sec. 1. A new section is added to chapter 41.32
- 5 RCW to read as follows:
- 6 (1) Beginning July 1, 1989, and every year thereafter, the
- 7 department shall determine the following information for the
- 8 retirement allowance received by each person who established
- 9 membership in the retirement system on or before September 30, 1977,
- 10 and who has been retired for at least five years:
- 11 (a) The dollar amount of the minimum retirement allowance as of
- 12 July 1, 1989;
- 13 (b) The index for the 1987 calendar year, to be known as "index
- 14 A":
- 15 (c) The index for the calendar year prior to the date of
- 16 determination, to be known as "index B"; and
- 17 (d) The ratio obtained when index B is divided by index A.
- 18 (2) The value of the ratio obtained shall be the annual
- 19 adjustment to the retirement allowance and shall be applied beginning
- 20 with the July payment. In no event, however, shall the annual
- 21 adjustment:
- 22 (a) Produce a retirement allowance which is lower than the
- 23 minimum retirement allowance as of July 1, 1988, or that amount upon
- 24 retirement:

- (b) Exceed three percent in the initial annual adjustment; or
- 26 (c) Differ from the previous year's annual adjustment by more
- 27 than three percent.
- 28 (3) For the purposes of this section, 'index' means, for any
- 29 calendar year, that year's average consumer price index—Seattle,

- 1 Washington area for urban wage earners and clerical workers, all 2 items, compiled by the bureau of labor statistics. United States
- 3 department of labor.
