



LEGISLATIVE UPDATE - Gordon Bowers, Legislative Chairman

WSRTA COLA bills in the 1989 session are the same as 1988 - automatic 3% COLA based on the Seattle CPI. There would be a five year waiting period - those who retired in 1984 or earlier would be eligible.

The Public Employees Retirement Coalition and the Washington State Coalition of Retired Education Employees have a bill that calls for a 5% COLA AND MEDICAL BENEFITS.

The Legislative JOINT COMMITTEE ON PENSION POLICY has not made a realistic recommendation to the Legislature on any COLA proposals by retired groups.

Rep. Maria Cantwell [44th Dist.] met with SNO-KING RTA Legislative Committee members Phyllis Fiege and Gordon Bowers and suggested strategies that have been effective with "COMPARABLE WORTH", the FAMILY INDEPENDENCE PROGRAM, and others. Those suggestions were 1. "BOW WAVE BUDGETING" - strategy of pushing eventual cost of any bill far into the future. 2. Roll back waiting period 7 to 9 years because of the large increase in teachers' salaries 1979-1983. 3. Forget the appeal to equity and fairness - falls on deef ears.

An appeal was made to Rep. Cantwell, asking her to talk with other FEMALE LEGISLATORS (one third of the legislature) and try for a "gentler, kinder attitude in the legislature." THANKS TO REP. CANTRWELL - SHE IS A SPONSOR OF OUR COLA BILL.

Our neighbor to the North, SNO-ISLE RTA had a special January meeting just for legislative matters. There is a strong feeling that WSRTA should hire a lobbyist and pursue legal research on possible redress in the courts. Their interest was rekindled by the two PERS class action suits in progress suing the State. The latest suit is on the question of "Average Final Compansation", and the effect on pensions - handled by the Seattle law firm of Reed, McLure, Moceri, Thoma & Moriarty. SNO-ISLE members (SNO-KING should do likewise) were urged to continue letter writing and phoning legislators for this session, bring resolutions to the WSRTA DELEGATE ASSEMBLY in June. They were also urged to write Washington members of Congress and Horace Deets, Executive Director of AARP, 1909 K St.NW, Wash. D.C. 20049 PROTESTING THE CATASTROPHIC CARE SURCHARGE THAT TARGETS ONLY MIDDLE INCOME RETIREES.

SNO-KING MEMBERS HAVE SOME CHANGES, NEW FACES REPRESENTING THEM IN DLYMPIA.

Also, when public hearings are held on WSRTA bills, SND-KING SHOULD SEND AS MANY AS POSSIBLE TO OLYMPIA. MILEAGE WILL BE PAID BY WSRTA @ 21¢ PER MILE, 4 people to a cer.




## COMMUNITY SERVICE COMMITTEE - Betty Puckett, Chairman
