(Edmonds City Park) are as follows: take SR 104 (Edmonds Way


to Edmonds)[DO NOT take arterial off-ramp to Edmonds-Kingston

US SENATOR GORTON sent a June urgent message to Washington residents regarding a bill now in Congress - HR 4245, that he states "If this legislation is allow to pass, it will increase taxes on Social security, cut benefits for senior citizens an average of 8.6%, and cut cost of living adjustments (COLAs). Enclosed was an opinion ballot - 'PROTECTING SOCIAL SECURITY' to be mailed to him. For more information, call his Seattle office - 553-0350.

CPR - NOW IT'S EASY - Please read READER's DIGEST, July, Pages 87-90 for a quick review with pictures and a clip out handy diagram for reference on how to give CPR. Did you remember the CPR cycle is two breaths, then 15 compressions done over nine to 11 seconds? Also, note in the article page 87, that in Scattle 50 to 60 percent of heart attack victims receive CPR from a bystander, and Scattle also has the nation's best record for survival after heart stoppage and CPR IS GIVEN

Regarding HEALTH CARE REFORM - the confusion continues, but AARP has a new 800 toll free number to update info on health care legislation. The free call number is 1-800 HLTH-CARE (1-4584-2273).

The Washington State Health Care Authority has announced that retirces' monthly health insurance premium will go down starting July 1, 1994. The State is contributing an extra \$28.50 to those not on Medicare, and \$11.40 per month for Medicare recipients. If your pension check does not reflect same, call the HEALTH CARE AUTHORITY 1-800-200-1004.

It was held at a mountain site that today has been made on Italian historical monument honoring the American, British and Italian soldiers who fought there. After returning to Milan they flew to Copenhagen, took a "Lay over" and used a Scan Rail pass to visit Norway. They visited Copenhagen, Oslo, Lillihamar, Trondheim, Bergen and the Soguefford area. SNO-KING HAD GOOD TURNOUT AT STATE CONVENTION

Sno-King RTA had 18 members attending the 1994 WSRTA Convention in Kelso. We were glad that Eleanor Robinson-Wallis NW-1 Representative on the Board was able to attend. Others from our Unit were: Jim Becker, Marion Bellows, Barbara Berg, Eleanor Bonano, Deborah Cooley, Joanne Dunn, Phyllis Fiege, Wes Grande, Lois Grasmick, Geneive Kimm, Betty Odle, Ed Osborn, Frances Peters, Betty Puckett, Ruthanne Warren and Georgianna Young as Unit delegates and two members as state delegates: Joan Brown and Eleanor Robinson-Wallis.

Sno-King received a number of awards: Membership-Consecutive all-time high (8 years), increased ADD membership, and increased retiree membership; Information Awards - Excellent award for our newletter and Excellent award for our Directory; and the Unit received the "Unit of Distinction" award.

LEGISLATIVE NEWS - Joanne Dunn, Chair 363-7843

Lee Ozmun, WSRTA lobbyist, was very well received at the June membership meeting. As usual, his speech was full of the latest information from Olympia, giving us guidance on what we can do to inprove our pension situation.

Lee said that the most important things we can do right now are to (1) contact members of the Joint Committee on Pension Policy (See list below), (2) contact members of the Legislature, and (3) work on the campaigns of candidates for the Legislature.

He urged us to personalize our messages to legislators, stressing that the most meaninful information we can give them is about *our own* personal situation and how it has deteriorated since we retired. He asked those in attendance to fill out a form showing the changes in their incomes and expenditures since retirement. If you did not attend the meeting, please fill out the form (see page 5) and return to me so that I can use the information when I contact legislators and forward it to Lee for inclusion in his report to legislators. We do not need your signature.

In your contacts with legislators, candidates for the legislature, and members of the Joint Committee, the message is simple: "Will you support a COLA? This is the situation we are in. (Insert your personal information.) We know you are very concerned about the effects of initiative 601 on the budget, but COLA improvement can be funded by using some of the surplus earnings of the pension fund. Are you willing to support this - and to provide leadership to bring it about?"

Legislators will meet in their caucuses at least twice before the next session begins. Ask them <u>specifically</u> if they are willing to speak up in those caucuses on behalf of retired educational employees. If they do, this will affect the members of the JCPP in time for proposals to come out of that committee.

Now is the time to write members of the JCPP because they are currently studying Plans I and 2 in order to determine what legislation they will recommend to the next session. They meet the third Tuesday of each month (except August). The June and July meetings deal with Plan 2, and the September meeting with Plan 1. Members are encouraged to attend. Call me at 363-7843 for specific information a few days before the meeting.

Now is the time to volunteer to work on candidates campaigns. Volunteer forms were handed out which will be given to the appropriate candidates. (See form on page 5 if you were not at the meeting.)

Lee's speech was preceded by a skit in which members Barbara Berg, Betty Odle, Frances Peters, Betty Puckett, and Georgianna Young, as reluctant volunteers, were reassured by "campaign manager" Phyllis Fiege about all of their many concerns! Doorbelling to leave campaign literature and telephoning will not get you in political arguments because you will be asked to refer questions directly to the candidate. Only an hour of work is warmly welcomed. You needn't fear knowing what to say when telephoning, because you would be provided with a short script and, again, asked to refer questions directly to the candidate. Don't worry about getting lost while doorbelling. You would be sent out with a partner—even better, bring your own!

Lee illustrated the very best method of increasing membership, attendance at meetings, and volunteering for political campaigns, by coming up to me, taking my arm and asking me to come with him to attend a meeting, to volunteer... This works and is something every one of us can do - and enjoy some time with an old friend at the same time!
