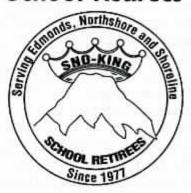

The cost is \$9.95. Advance registrations are required. Make yours by calling Betty Odle (206-525-8276) by March 15.

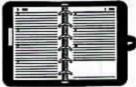

Norman "Bob" Arnesen died from cancer on November 27, 2001, at the age of 77. Born in Canby, Oregon, Bob served in Europe as a staff sergeant during World War II. He attended Northwest Nazarene College where he met his wife, Ethel, and then attended Seattle Pacific College.

During 30 years with the Shoreline School District he taught fifth and sixth grades for nine years and was a principal for 21 years. He was president of the principals' association and served as editor of the state principals' newsletter.

He received a number of community service awards. After retirement he served as facilities administrator of the North Seattle Church of the Nazarene and taught English to Chinese immigrants. He is survived by his wife, Ethel, three children and seven grandchildren.

John P. Miles died February 4 at the age of 65. He was born in Minneapolis in 1936. John spent many years in the Edmonds School District working as a classified employee.

Johns Hopkins wants you to know

With the plethora of health info in all media, it seems best to just hilight those that come from very reliable sources. Johns Hopkins wants to reassure everyone that cholesterol lowering drugs (statins) are recommended as the first choice for people with high cholesterol, and too much of the LDL (bad cholesterol). Statins are the safest and best medications for preventing heart attacks and strokes. When taken properly, they can achieve a 50% reduction in LDL cholesterol.

Approximately 13 million Americans are now taking statins, and side effects are minimal. Close supervision by a doctor is recommended. Source: Johns Hopkins Medical Letter, February 2002, P. 3.

Believe it or not

Alcohol can be both a risk factor and a preventative measure for strokes, but binge drinking increases the risk of stroke. Moderate drinking—no more than one drink daily for women and one or two drinks daily for men, can increase "good" hi-density lipoprotein cholesterol and decrease blood-clotting tendencies. Both factors may contribute to a reduce risk of ischemic stroke. Source: Mayo Medical Essay, February 2002, P. 2.
