LEGISLATIVE HIGHLIGHTS



Please save the yellow insert (Essential Points, COLAS) in your October WSRTA Journal. Newly appointed Rep. Jeannette Wood, 21st District, says it is the most useful and informative of all materials she has received as a new legislator.

All candidates for the legislature in the state have been mailed a questionnaire on their positions - COLAS, and whether they would sponsor WSRTA COLA bills. Results for each legislative district are expected to be available before November 8.

Regarding Medicare and Catastrophic Care, AARP HIGHLIGHTS, October 1988, has some updated Medicare premium costs, "In 1989, the minimum premium for Part A & B coverage for an individual will be \$31.10 per month. The highest premium possible will be \$31.10 per month plus an income tax liability of \$800, or \$1173.20. Couples with both individuals elibible for Medicare will pay double these amounts."

Medicare basic cost per person will rise to a monthly premium of \$42.60 in the next five years. Some Congress members are already at work to effect changes during the 1989 session. California Rep. Anthony C. Beilenson wrote in the July issue of RETIREMENT LIFE entitled NEGLECTING WHAT THE ELDERLY NEED MOST -- WE SHOULD GO BACK TO SQUARE ONE ON CATASTROPHIC PROTECTION. He explained in his article, "Medicare beneficiaries are already unhappy about paying \$24.80 a month, as all lawmakers know from the huge amount of mail and number of phone calls we have received protesting this year's \$6.90 monthly increase. It is difficult to imagine Congress asking the elderly to pay the \$42.60 per month required five years from now under the bill; it is inconceivable that we will then ask them to pay even more than that, even for the most sought-after benefits."

Additionally, there has been much concern over the method of financing the catastrophic surcharge--targeting middle income senior only. In line with this problem for retirees, the WSRTA Coordinating Council NW-1, representatives from Snohomish, Skagit, Whatcom, and Island-San Juan counties voted at their October 6 meeting to request the WSRTA Executive Board contact AARP Executive Director Horace Deets to urge AARP TO PRESS CONGRESS FOR A RECONSIDERATION OF THIS EXCESSIVE TAX INCREASE. Individual letters are very effective, also, both to each Congressman and to AARP Executive Director, 1909 K Street, NW, Washington, DC 20049. The USA is the only industrialized nation in the world that does not have a comprehensive medical care plan for its citizens. Your letters will help!

BULGAR SLAW

1 1/2 c. bulgar wheat

3/4 tsp. salt

3 c. water

Combine and cook 15 minutes or until water is absorbed. covered. Cool.

Combine:

1 1/2 c. mayonnaise

1/2 c. cider vinegar

3/4 tsp. crushed dill weed

3/4 tsp. mustard(dry)

5 T. sugar

3/4 tsp. mustard(dry)


3/4 tsp. mustard(dry)

3/4 tsp. Tabasco

Add mayonnaise mixture to wheat and chill, covered, several hours or overnight. One hour before serving add the following:

4 1/2 c. shredded cabbage, 1 1/2 cups finely chopped celery, 1 1/2 cups shredded carrots. Add tomato quarters for garnish.
