Committee Reports

As a community service project, Rita suggested that we can write congratulatory letters to students who have read the most books at Highland Terrace Elementary School in Shoreline. Jack also suggested bringing a sign-up sheet to the October luncheon for other retirees to write letters to students.

► Update on your health Holiday cheer helps you stay healthy

UPDATE ON LASER HEART SURGERY

According to Health News, October 1999, published by the Massachusetts MEDICAL SOCIETY, the last ditch procedure for relief of chest pain (angina), is using a laser to drill tiny holes in the heart wall. To perform this treatment, the chest does not have to be opened The laser functions through a slit between the ribs and a series of tooth pick size holes are drilled. Patients recover faster and the cost is much less. Since we reported on this transmyocardial revascularization surgery several month ago, three new studies on same found that the patients were able to walk farther without pain. However, Dr. Anthony DeMaria, Associate Editor of Health News, cautions that "The objective evidence that it works is not definitive, but once patients with life-limiting angina have exhausted all other options, I think TMR is worth a try." NEW ALZHEIMER STUDY

A biotech company (AMGEN) in Thousand Oaks California reports that their researchers have found the enzyme that causes brain cell damage, opening the door to developing drugs that might block it, or slow the disease. This enzyme had eluded researchers for many years, but it was known to exist, given the name beta-secretase. The study was reported by Dr. Martin Citron in the *Journal Science* and *New York Times* (October 22, 1999)

HOW ABOUT NEW BRAIN CELLS?

Up to now, brain researchers believed that the thinking center/cortex of the brain was unable to grow new cells or neurons to replace those that wear out. As reported in Journal Science October 15, 1999, Princeton University's team led by Dr. Elizabeth Gould, injected monkeys with a compound called bromodeoxyridine, or BRDU, that is taken up by cells in the process of making new cells. Examination of the brains a few hours later showed that the cells in one area of the brain took up the BRDU, proving that they were dividing, and making immature neurons. A further exam a week later showed the new neurons had become a part of the cortex. How these neurons function is not known, but is cheerful news that our old brains can be rejuvenated. Don't hold your breath on this one - maybe our grandkids will benefit!

WANT TO LIVE LONGER?

The *Mayo Clinic Health Letter* (November 1999), has some happy suggestions for

Christmas time and all other days of your life. In a seventeen-year study of 7,000 Californians, results show that the people who enjoy "social support" - good relationship with family, friends and partners - tend to live longer, healthier lives. Mayo writers summed it up this way: "Older age can be a lonely time, but it doesn't have to be. It can be a time of opportunities. You may have more free time to make new friends, forge new bonds with family or volunteer in your community. One of the best support sources is a healthy, fulfilling long-term relationship. Make that relationship a priority in your life. Take time to be there for each other. Encourage family members who aren't living with you to communicate on a regular basis. E-mail can be a handy and inexpensive way to stay connected or a phone chat instead of a machine. In addition, make time to regularly do something with your friends. If you don't have many immediate social contacts, think about building them. An important first step is to "get out there." If you're outgoing, it shouldn't be too hard. If you're not, take it one person at a time. Asking people about themselves and their work or hobbies is a good icebreaker. Although it may take some effort, staying socially connected is important for your mental and physical health and your longevity." HAPPY HOLIDAYS!!!

One of our favorite small towns is



Seafood cafes cluster along the beach, a marina takes in visiting boats, and a luxury hotel sprawls across one end of the island. 
