have returned. Mexico was great, sunny, warm and getting more expensive with each year. Too bad our TRS checks are not keeping up there either. Thanks to Jack Rogers for taking over my duties.

At our March meeting District Rep. David Thurman explained the three-tiered strategy aimed at getting some control of our retirement system and money into our retired members' hands.

The first was LEGISLATIVE. WSRTA didn't fare too well there: (1) the Cathy Wolfe Bill which would have expanded JCPP membership to include both retired and active members did not get out of the House Appropriations Committee and (2) continued underfunding of the pension system, i.e. state contribution rate reduction to TRS. (Both D & R budget proposals and the governor's budget proposal reduced the rates.)

The second is the LAWSUIT. Jack Rogers' has information about the WSRTA lawsuit.

The third tier is the INITIATIVE which has been filed by Stan Bianchi of Whatcom County Retired Teachers Association. The effect of the initiative is to replace the JCPP with a Pension Management Board. Among their responsibilities: review pension policies, treat the pension funds as a trust, and establish pension contribution rates. (Call Rita to get a copy of the initiative for complete text.) While WSRTA or Sno-King has not taken an official position on the initiative to replace the JCPP with a Pension Management Board, it is printed and available.

Dave was very positive that we are moving forward and is confident some action will occur. Please keep informed about these vital issues.

Health tips for You

NEW, SUPER HI-TECH CURES

Egyptian doctors prescribed herbal medicines such as saw palmetto for treatment of prostate problems in the 15th century BC, according to NW Hospital Med-Info and The Journal Of American Medicine (vol. 840, #18). Dr. Phillip G. Pearson, urologist at NW Hospital said, "In Europe, 75 to 80 percent of the initial treatment for benign prostate hyperplasia (BPH) is herbal. In the US, 10 to 15 percent of the initial treatment is herbal, but the effectiveness of herbal remedies for prostate is still being researched and that any therapy for medical condition should be used with common sense and some precaution."

Curious, I checked several drug stores and found saw palmetto products with labels stating, "To be used for prostate problems." Probably, the 15th century BC doctors would have gotten a chuckle out of this product's lasting popularity for so many centurie.

WONDER DRUG

Exciting "new" health benefits from our old friend aspirin. At last, a low cost drug that is used worldwide is getting credit for curing more than a headache, pain or fever. Aspirin, used since 1899, is now being credited in new studies that indicate it is helpful in fighting a wide range of serious illnesses. For example, regarding Alzheimer's, Dr. Charles H. Hennekens, Miami University School of medicine says, "Elderly people who take aspirin have a lower rate of

cognitive loss, so aspirin may have an impact not just of Alzheimer's, but on the large number of patients who experience memory loss with age." On diabetes and aspirin,

the American Diabetes Association recommends low doses aspirin to reduce the development of cardiovascular disease. Regarding aspirin and cancer, the American Cancer Society studies show that nonsteroidal anti-inflammatory drugs, including aspirin, inhibit tumors including cancers of the colon, esophagus and stomach, according to Dr. Michael Thun.

On heart attacks and aspirin, though aspirin has been useful in preventing heart attacks, the FDA went a step farther in 1998 advising individuals experiencing symptoms of a heart attack to immediately chew two aspirin. Chewing causes quicker absorption than swallowing whole-every second counts.

Dr. Hennekens cautions that regular aspirin use may not be appropriate for people with digestive disorders or gastrointestinal bleeding. It is not recommended for children or teens. But Dr. Hennekens still says, "I think aspirin is the wonder drug of the 21st century." For more information on this, see the *Reader's Digest* article by Harriet Webster, March 2000, pp. 34-39.

This bill has passed, but needs a foot in the door funding of one million dollars. The legislative session next year should have this as a #1 priority. NW-1 COORDINATING COUNCIL MEETING

Five Sno-King members traveled to Mt. Vernon on March 7 for the last Co-ordinating Council meeting of this year. Reports were heard from various state committee members, including our own Gayle Bromley who serves on the Communication Committee. WSRTA's membership chair reported on the results of the membership drive, which hasId as its goal for every local to increase its membership by 10%. Some small locals have achieved that goal. Sno-King's quota was to increase by 126 members. We made the 5% threshold with 1259 members as of March 1. There was a recommendation that WSRTA hire some paid membership recruiters. We heard a detailed report from David Thurman regarding the three-tier approach to improving our pension system. Each local president also gave a report about the activities of his/her local. It was an informative meeting.
