For those of you new to SKSR, and those of you who need a review, the the state organization, Washington State School Retirees Association, is divided into eight districts. We are in the Northwest One District along with Whatcom, Skagit/Island/San Juan, and Sno-Isle. On October 6, 2014, five members of SKSR attend the NW 1 regional meeting in Mt. Vernon. Edie Moersch, WSSRA President, was also in attendance and thanked many individuals and groups for all the work they have done thus far.

State committee reports were given with the most pertinent of the state reports being the Legislative report. (See Rita Requa's article in this bulletin.) A new ad hoc group, The Select Committee to Reduce Convention Costs, gave it's first report. In order to balance the location of conventions from falling more heavily on the east side of the state where the costs are lower, they are looking at different ways to fund or subsidize this event.

Each unit gave a report of their activities. Peter Diedrick, our Legislative Coordinator, then discussed the importance of this legislative session, from potential shifts in the House and Senate to the importance of meeting directly with legislators. Rita Requa made a proposal regarding attending the opening day of the legislature on January 12, 2015. The plan is to have at least one member from each unit for each legislative district represented in that unit.

Our unit introduced a motion regarding a local and state dues' increase which was followed by much discussion. The motion passed and is being sent to the WSSRA Executive Board.

You may have taken advantage of the annual TRS Plan 3 January rate change period to adjust your defined contribution percentage in the past. Due to conditions of the recent IRS re-qualification of TRS Plan 3, January 2015 is the last time you will have this opportunity to change your rate without changing employers. If you would like to take advantage of the final rate change flexibility period in January 2015, you will need to complete a TRS Plan 3 Contribution Rate Change Form and turn it in to your employer between January 1 and 31.

Sno-Isle has issued a warm invitation to Sno-King members to a legislator panel discussion on Tuesday, November 18. The topic will be what the citizens of Washington State may expect to see during the 2015 Legislative session. The discussion will be held between 10:30 and 11:30 am in the fellowship hall of Our Savior's Lutheran Church at 215 Mukilteo Boulevard in Everett. It will be followed by a catered lunch starting at 11:30 am for the price of \$10.

Legislators from the 21st, 38th, 39th and 44th Legislative Districts will be speakers. Sno-Isle plans to invite superintendents of area school districts from Edmonds in the south to Arlington in the north as guest attendees. Also invited are members of Retired Public Employees Council, Chapter 6, a group of 450 public retirees with legislative concerns similar to ours.

As Washington State retirees, we realize that our individual and collective futures may certainly be affected for better or worse by the actions of the 2015 legislative session. Our concerns relate most closely to the state maintaining the actuarially recommended payments to the state pension funds, preserving the defamed benefit pension plans for future state and public employees and protecting the current \$150 monthly Medicare Eligible Healthcare Subsidy for eligible members of the Public Employees Benefits Board health plan.


