Legislative News/Oct. 2014

WOULD IT MAKE ANY DIFFERENCE TO YOU IF YOUR PENSION CHECK WAS REDUCED BY \$150 A MONTH?

That reduction is what some believe will be on the legislative agenda come next January when the Legislature convenes. It was rumored last session that the \$150 Medicare Subsidy would be taken away. Your pension check would not be reduced, but if you are in any of the PEBB health care plans and are on Medicare, your health care premium would rise by \$150, making your spendable income reduce by \$150.

The subsidy was \$182.89 in 2011, however it was reduced the following year to the current level. The current Medicare Retiree Subsidy is \$150 per member per month or 50% of the health plan premium, whichever is less. The subsidy is authorized by the legislature in the operating budget. For the past 3 years, WSSRA legislative priorities have started with "Oppose additional cuts to retiree health benefits."

APPLICATION PERIOD NOW OPEN FOR EDUCATOR GRANTS

If your are an active (working) member of any school employee group that interfaces with students, you qualify to make application for an SKSR grant of up to \$200 to facilitate your work with those students. Innovative members in the past have used their funds for such things as field trips, art materials, books, computer programs, PE equipment, educational games, visiting experts, etc. This past year we awarded nearly \$7000 to a record 42 recipients. SKSR enjoys recognizing and supporting initiative and creativity and since the program's inception during the 1998-1999 year has awarded a total of almost \$48,000 in grants.

Applications are due by Thursday, November 6th and the process is simple! Just submit the following:

- 1. A few sentences explaining what item or resources you would purchase and the <u>intended effect/impact on your students</u>
- 2. Amount of money requested
- 3. Your name, address, grade level (if a teacher), school, and district
- 4. Principal's/Program Manager's name, email address, school address and phone number
- 5. Usual day/time of your regular staff meetings

To bring you up-to-date on the Sno-King Scholarship Fund and for those of you who are not familiar with it, here is a look at just how those funds are being used. Each spring our Sno-King unit awards four scholarships to students who are planning to pursue a degree in Education. These students come from high schools within the Edmonds, Northshore, and Shoreline School Districts. As our funds increase, we have periodically been able to also increase the amount of the scholarships. We're very pleased to tell you that beginning with the 2015 awards, we will be in a position to increase the awards from \$1200 to \$1500. Thanks again to all of you who have helped make this possible.

In addition, about 8 years ago, one of our members left a substantial legacy to Sno-King which has allowed us to offer the Sno-King scholarships as "renewable" for 3 additional years, provided the student continues in the field of Education. Our original investment is currently higher than what we started with, in spite of having already paid out more than \$85,000 in renewable scholarships.


