#### LEGISLATIVE UPDATE - GORDON BOWERS



The new WSRTA Legislative Chairman is NEAL NOGLER, from Centralia, replacing Cal Watness who is now president elect of WSRTA.

The following goals for 1990 were adopted by the Legislative Committee and approved by the WSRTA BCARD and DELEGATE ASSEMBLY on June 6, 1989:

- To work with the Joint Committee on Pension Folicy to support legislation providing a capped 3% COLA to begin at the same age as Plan II retirees.
- To change the Flan II retirement system so that the age for full retirement benefits be age sixty.
- To work closely with WSRTA's affiliates--AARP/NRTA--to effect some changes in Catastrophic Care including:
  - a. More control of health care coverage costs,
  - b. Broadening of the base of funding and,
  - c. Allocation of tax dollars-from the federal budget to cover the costs of the program.
- 4. To consider contracting a part-time public relations person, a public relations firm and/or a university to assist in carrying out the WSRTA Legislative Goals and be responsible to the State Legislative Committee.
- To seek a STATE FUNDED HEALTH CARE contribution for TRS retirees to be used for medical, long-term care and/or dental insurance.
- b. To support tax and spending reform legislation to ensure an equitable broad tax base to provide funding for State programs.
- 7. To continue participation with retiree groups in the Coalition.

Also, the Delegate Assembly approved a resolution to NRTA/AARTP and Congress that the present session of Congress be urged to revise the funding provisions for Catastrophic Care.

No legal action will be considered on COLA problems for the time being. The Joint Committee on Pension Policy (Legislature) will continue to meet and study the COLA problem for the 55% who do not get the 3% COLA NOW IN EFFECT.

- WHEREAS, the Catastrophic Medicare Act of 1988 does not do what it purports to do, in that it does not provide maintenance care for persons suffering from such disabling catastrophes as stroke, accidents, and numerous illnesses such as Alzheimer's or Parkinson's; and,
- 2. WHEREAS, the Act provides that Medicare coverage will include only 80% of what it determines to be the reasonable charge for doctor and other Part B services and basically disregards the fact that most doctors will not accept Medicare assignments on the basis of the "reasonable charge"; and,

 WHEREAS, nothing in the Act advocates any measure to halt the spiraling cost of health maintenance, an inflationary factor far greater to seniors than any other

single factor; and,

4. WHEREAS, the method of financing the limited coverage provided for in the Act, in attempting to solve a problem that concerns the general welfare of all, is discriminatory, regressive, and sets a dangerous precedent by placing a tax burden on a specific group of people based on age--most of whom can ill afford the additional taxation; and,

5. WHEREAS, it has been determined that less that ten percent of those who will

pay this senior citizen tax will ever receive benefits from it:

NOW, THEREFORE, BE IT RESOLVED THAT WSRTA URGE NRTA/AARP LEADERSHIP AND THE PRESENT SESSION OF CONGRESS TO REVISE THE FUNDING PROVISIONS FOR CATASTROPHIC CARE IN LIGHT OF PARAGRAPHS 4 and 5, TO PROVIDE A PROGRAM BASED ON A METHOD OF FINANCING THAT WILL BE EQUITABLE TO ALL.
