

SCHOLARSHIP FUND GUIDELINES

The scholarship initially is to be a minimum of \$250.00 per individual and from one school only from Edmonds, Northshore or Shoreline Districts in rotation. As the fund grows, scholarships will increase and hopefully multiply.

The starting objective for a permanent fund would be \$5000.00. The accruals could be disbursed each year.

Criterea for selection: Education Major; Scholarship; Resume of performance, activities and personal goals

Selection Committee to consist of three members of the Sno-King Retired Teachers Association.

Fund raisers:

At the time of the passing of a member, the bereaved could suggest that memorials be made to the fund in the deceased member's name.

Donations could be made to the fund in honor of someone's birthday, anniversary, etc.

Bequests made to the fund in a member's will or from life insurance benefits.

Fund Raisers such as pot luck salad luncheons with a \$2.50 donation, garage sales, etc.

Direct contributions made by members.
